2018-2019 Open Enrollment: Collateral updates include new design and new student photos. Posters were placed all across NEC area in a targeted outreach effort. Enrollment numbers are tracking similar to last year. Lottery will take place on February 10^{th, 2018}.

Stacev Walter reported the following:

BCS's Tour Program provides educators the opportunity to observe the school's unique educational practices and bring ideas and best practices to their own school communities. Last year, BCS hosted 26 tour groups from 6 countries and 29 organizations (125 participants). This program exemplifies two aspects of the BCS mission, "being a model of educational innovation" and global citizenship.

Jennifer Anderson-Rosse reported the following:

1. Fourth Grade Zoo Habitat PBL Presentation

BCS teacher Robin Boynton, Associate Teacher Ryan Young and 4th grade students provided an overview of their recent PBL unit on Zoo Habitats, using the driving question: *How can we create an ethical habitat for two given animals?* Students studied specific animals and biomes, integrating art, science, and written opinion pieces in their final habitat designs. The students demonstrated the interactive components they designed in the Maker Space using Makey Makey kits. The teachers reported that all 4th grade students were invited to the California Steam Symposium in December to showcase their final projects.

Andrea Eyring reported on the Ad Hoc nominating team. Founding Superintendent Wanny Hersey and Board members Ann Waterman Roy and Rich Ying are confirmed to serve.
